## Making transport policies more clilmate-friendly

Employers can motivate their workforce with different benefits. This also includes contributing to employees' travel expenses which even reduces tax and social spending. The payment of a travel allowance for commuting to work or for travelling in leisure time is the prerequisite for this.

The VBB-Firmenticket (company ticket) and the Deutschlandticket Job (Germany ticket job) for public transport buses and trains are valid around the clock, 365 days a year and can be used for any number of journeys in the area of validity. The higher the employer's contribution to the costs, the lower the employee's own contribution to the ticket purchase.



## **Interested?**

The local transport company offers these tickets. There is nothing to prevent the conclusion of a framework agreement for one of the tickets if the employer pays and confirms the mandatory minimum amount of the travel allowance.
